Our mission is to help children and adults with enduring intellectual, developmental and physical disabilities live as independently as possible, be included in the community and function at their highest potential.

SYSTEM NAVIGATION OBJECTIVES

The need for timely and accurate information is vital. Therefore, AWS Foundation has made system navigation a top initiative. We are engaging the community to establish a vibrant online and support staff presence that will guide people to resources and information expanding their awareness of and access to organizations, programs and services. In addition, we believe that a comprehensive system identifying all of the community's existing resources will reveal gaps in services creating new opportunities to help individuals with enduring disabilities.

FUNDING

In support of the System Navigation Initiative, AWS Foundation will grant up to one million dollars to further develop and strengthen Northeast Indiana's access to timely and accurate information.

WHAT ARE WE DOING AND WHY?

Through focus groups and ongoing interactions with non-profits, service agencies, families and caregivers, we continue to hear a prevailing theme of frustration and disappointment that access to information and missing information is limiting lives. From next steps after a diagnosis through life transitions and aging, individuals are continually challenged on what is next, where to go for information and what assistance is available. Simply put, understanding and navigating a disjointed system was identified as one of the biggest challenges faced by individuals and families.

To address this issue, the goal of the system navigation initiative is to make much needed information easy to locate, more accessible and understandable. We believe achieving this goal will greatly expand our community's ability to serve individuals with disabilities.

Over the last year, we have worked to learn more about the current process, where gaps exist and what is desired to improve system navigation - not only to better support individual needs - but to have a positive impact on early diagnosis and quality of life.

Using the information gleaned from this RFI, AWS Foundation expects to:

- Evaluate existing resources being provided by participants

- Identify potential partnership opportunities
- Explore areas to expand existing services and develop new services to effectively support the needs, wants and preferences for information as identified by those being served
- Provide funding

Your organization has been identified as a potential partner and is being invited to consider this opportunity by participating in the foundation's selection process. We will base our selection decision on numerous factors which include, but are not limited to, the following:

- History of experience working with individuals and families living with intellectual, developmental and physical disabilities
- Services offered and the ability to partner with other organizations
- Management team and experience
- Existing funding sources and financial stability
- Ability to support the foundation's System Navigation Initiative
- Willingness to maintain a strong market presence in Northeast Indiana.

RFI responses will be reviewed and the top two potential partners identified. A meeting and site visit will follow to address any questions either party may have prior to selecting a community partner.
